## **INVOCATION**

Councilman Gerome McLeod gave the invocation.

Dillon County Administrator, Claude Graham submitted his resignation to the council due to medical reasons effective no later than 8:00 PM on July 27, 2022

Chairman Buzzy Finklea announced that Harold Moody and Stevie Grice would be attending the meeting by phone.

## **APPROVAL OF AGENDA**

Attorney Ken Dubose suggested to council that the agenda be amended because the administrator resigned effective after the meeting. He stated that under the Home Rule Act it says the county council shall employ an administrator who shall be the administrative head of council which means that the council has to have an administrator. He stated that because this is considered an unforeseen or emergency circumstance that the agenda needed to be amended to provide as a matter on the agenda in executive session that employment by Dillon County Council be added to the agenda and to provide compensation for services and other matters to be determined by council. A motion was made by Gerome McLeod to amend the agenda and go into executive session and once they come out of executive session name an interim administrator. It was seconded by Jamal Campbell. All were in favor.

## **Ordinance Reading**

## J A G GRANT AWARD – SHERIFF DOUGLAS PERNELL

Sheriff Douglas Pernell spoke in reference to a JAG Grant that was received in the amount of 13,992.00. With those funds this year, the sheriff's office will be purchasing a Mobile Radio - 7229.91, a Portable Radio - 6491.78, 2 Flash Lights - 207.36 and 3 Batteries - 62.95 which is a grand total 13,992.00 and he stated that this is at no cost to the citizens of Dillon County.
