### **Noise Ordinance**

In reference to a possible solution to a problem for Professor Eaddy who addressed council concerning shooting at night and loud noise in his neighborhood. He stated that Chief Hamilton investigated and said that this was not a shooting range and the shooting was for their enjoyment on their own property. He does not want to a noise ordinance to be passed if they don't have to at this time. The property owner agreed to not shoot on Sundays or after 10:00 at night and also said that they didn't mean to offend any of the neighbors. Dennis Townsend also said that there would have to be a lot of provisions to be considered in order to enforce a noise ordinance and would like for that to be a last resort and if everyone holds to their agreement there will be need to enforce a noise ordinance. In conclusion he said that he would like for Professor Eaddy to recognize and let the neighbors know that he did address their issue and that this may not resolve it but this is the first step to stop it.
