A RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION BY DILLON COUNTY TO THE DIVISION OF COMMUNITY GRANT PROGRAMS OF THE SOUTH CAROLINA DEPARTMENT OF COMMERCE.

A motion was made by Stevie Grice and seconded by Harold Moody to approve the application for a Community Development Program Community Enrichment Grant in the amount of \$500,000.00 to purchase a fire truck for Station 2.and that Dillon County shall provide a local match of not less than 10% (\$50,000.00) of the total CDBG cost plus any overages needed to complete the project. All were in favor.

NATIONAL FAITH & BLUE WEEKEND

Pastor James Orr spoke about the National Faith & Blue Weekend. The organization started in Atlanta Georgia in 2018. He found out about this program thru Interim Police Chief of Latta, SC, Zane Bryant. He also spoke about Empowerment In Action which is

a group in that he and Moses Heyward are a part of and they're working to help stop crime and violence among the young people by going into the communities. They have gotten support from all of the local law enforcement agencies. He said that Sheriff Douglas Pernell has worked really hard to help out he has also been in touch with the schools and DJJ. They now have over 20 churches and pastors involved. He came to personally invite the County Council Members to be a participate or be a part of the National Faith & Blue Weekend Event which is scheduled to be held on October 8, 2022. He stated that they have received donations of over 1500.00 and they will be giving out t-shirts, hotdogs and hamburgers and other things also. They will also be playing softball, volleyball and basketball. He said that this will be an opportunity for the citizens to get to know the officers in a nonconfrontational setting and to know that they are servants of the public and that they are here to work together. He gave out flyers along the dates of upcoming events. With permission from council, he said a prayer of protection, leadership, unity and guidance in decision making for them.
