Since the implementation of a new, integrated tax processing system on September 1, 2015, all collections are deposited upon receipt and are posted to specific local jurisdictions when the returns and payments reconcile. We specific return and payment reconcile, the local government is credited with allocations from that specific return. Prior to the implementation of the new system, allocations were credited immediately based on receipt of the return prior to the correction of any error or coding issue on the return.

Tax figures reflect actual tax payments received and net adjustments made during fiscal month (for both open and closed entities), regardless of period covered or form of payment.
