## **ORDINANCE READING NO. 23-09 FIRST READING**

Ordinance Reading No. – 23-09 FIRST READING – AUTHORIZING THE ISSUANCE AND SALE OF A NOT EXCEEDING \$1,500,000.00 GENERAL OBLIGATION BOND, SERIES 2023, OF DILLON COUNTY, SOUTH CAROLINA; FIXING THE FORM AND DETAILS OF THE BOND; PROVIDING FOR THE PAYMENT OF THE BOND; AUTHORIZING THE CHAIRMAN OF COUNTY COUNCIL AND COUNTY ADMINISTRATOR TO DETERMINE CERTAIN MATTERS RELATING TO THE BOND; PROVIDING FOR THE PAYMENT OF THE BOND; THE DISPOSITION OF THE PROCEEDS OF THE BOND; AND OTHER MATTERS RELATING THERETO.

## **TERESA MOODY – ORDINANCE & ZONING REGULATIONS**

Teresa Moody who stated that she is a lifelong resident of Dillon County and has lived at her current location for thirty-six years and she is a Marion County employee and works as the Director of Voters Registration Elections. The reason for her speaking to council was concerning Zoning Ordinance for her address and adjoining properties. She went on to say that in early April she called the Dillon County Code Enforcement Office to and spoke to Emily to question if roosters were allowed on the property beside her and was told the property was a RS2 which is residential and not allowed and stated that Emily said that she would have Mr. Price call her back but she said that she never received a return call so she called Mr. Price back on April 11 to find out if the roosters were prohibited but was told that the property was a RS2 and said that she never got a clear explanation from him only that he there was no law saying how many he could or couldn't have but he would go speak to her neighbor. She said that on April 17, 2023 she also spoke to Councilman Kenny Cook Jr about her concerns, who stated that he would speak to Mr. Harper and give her a call back. She said that she also spoke to Mr. Harper on April 28, 2023 concerning the rooster situation who told her that there was no ordinance to prohibit the roosters and advised her to consult with an attorney to interpret the zoning ordinance. She received copies of her zoning ordinances and was told that a lot of information that she got online was not correct and she stated that it needed to be taken down if it was not correct. She said that she has made multiple visits to the code enforcement Office and nothing had been resolved but after a committee meeting was held on June 13, 2023 and after that meeting, she was called to file a formal complaint. She said that she has personally counted at least 100 roosters and they're located outside near her bedroom window. She said that she has filed a noise complaint with the sheriff's office and has received threating messages. She asked that council enforce the county zoning regulations.

A recommendation was made by Dennis Townsend to refer this issue to the county administrator as well as the legal counsel so that he may move forward by bringing a resolution and that they respond back to Ms. Moody.
